#### **CONCLUSIONS OF LAW**

The crime of Child Neglect 1 as defined in ORS 163.547 is listed in ORS 342.143(3). The Commission is required to revoke the Oregon Basic Teaching License issued to Anne Marie Cockrell and revoke her right to apply for a license pursuant to ORS 342.175(2).
