16	him of his opportunity for hearing. The notice was sent via U.S. First Class Mail and U.S.
ı7	Certified Mail Receipt 7001 0320 0005 0740 8681. The certified mail receipt was signed and
18	dated on July 30, 2002.
19	The Notice of Opportunity of Hearing, dated July 25, 2002, and signed by Victoria
20	Chamberlain, Executive Director, stated:

In denying your license the Commission has followed and will follow the procedures set out in ORS 342.176 and 342.177, in conformance with ORS 342.143(4). Attached to this notice is a copy of the procedures, right of representation and other rights of parties relating to the conduct of a hearing as required under ORS 183.413(2)."

The Commission adopted a Stipulation of Facts, Public Reprimand and Order in the matter of the Teaching License of Gary Stephen Wiese on January 19, 2000. 10 11 **CONCLUSIONS OF LAW** Gary Stephen Wiese made a false statement on his application for renewal of his 12 teaching license. This action constitues a basis for denial of licensure and discipline pursuant to ORS 342.175(1)(e), OAR 584-020-0040(4)(c), and OAR 584-050-0006(1). 15 ORDER 16 The Commission denies issuance of a teaching license to Gary Stephen Wiese.
